



GST REGISTRATION

A comprehensive, multi-stage, destination-based tax levied on the supply of goods and services. Any business meeting the specified turnover criteria must register for GST to comply with tax regulations.



PROCESS

1 Fill the Form

Visit our website and complete the GST registration form.

Submit the necessary documents for verification.

Make Payment

Complete the payment through our secure company payment link.

Application Submission

We apply for GST registration on your behalf via the GST portal.

Receive ARN

You will get an Application Reference Number (ARN) within 2 working days.

Get GST Certificate

If documents meet government guidelines, you will receive your GST certificate within 7-15 working days.

WHO NEEDS GST REGISTRATION?

E-commerce operators and businesses selling online. Annual turnover $e_{XCeeds} \neq_{AO} lakhs$ (for Services).

Inter-state suppliers of goods and services.



Agents of a supplier & Input service distributor

Businesses liable to pay reverse charge.

Casual taxable person / Non-Resident taxable person Those paying tax under the reverse charge mechanism



FREQUENTLY ASKED QUESTIONS

Who needs to register for GST?

Any business with an annual turnover exceeding ₹40 lakh (₹20 lakh for service providers) must register for GST. Certain businesses, like e-commerce sellers and inter-state suppliers, need to register regardless of turnover.

Is GST registration mandatory for small businesses?

If your turnover is below the threshold limit, GST registration is not mandatory. However, voluntary registration can help you avail input tax credit and expand your business.

What is ARN in GST?

ARN (Application Reference Number) is a unique number generated after submitting the GST application. It helps track the status of your application.

What happens if I do not register for GST?

Non-registration may lead to penalties, legal actions, and restrictions on doing business legally.


