FREQUENTLY ASKED QUESTIONS

Who needs IEC registration?

Any individual, company, or organization engaged in international trade (import/export) must obtain IEC.

O2 What is the validity of an IEC?

IEC is issued for a lifetime and does not require renewal. However, it must be updated annually on the DGFT portal.

Can I modify or update my IEC details?

Yes, IEC details can be updated or modified on the DGFT portal. Updating IEC annually is mandatory.

O4 Can IEC be canceled?

Yes, if you no longer require IEC, you can apply for its cancellation through the DGFT portal.
