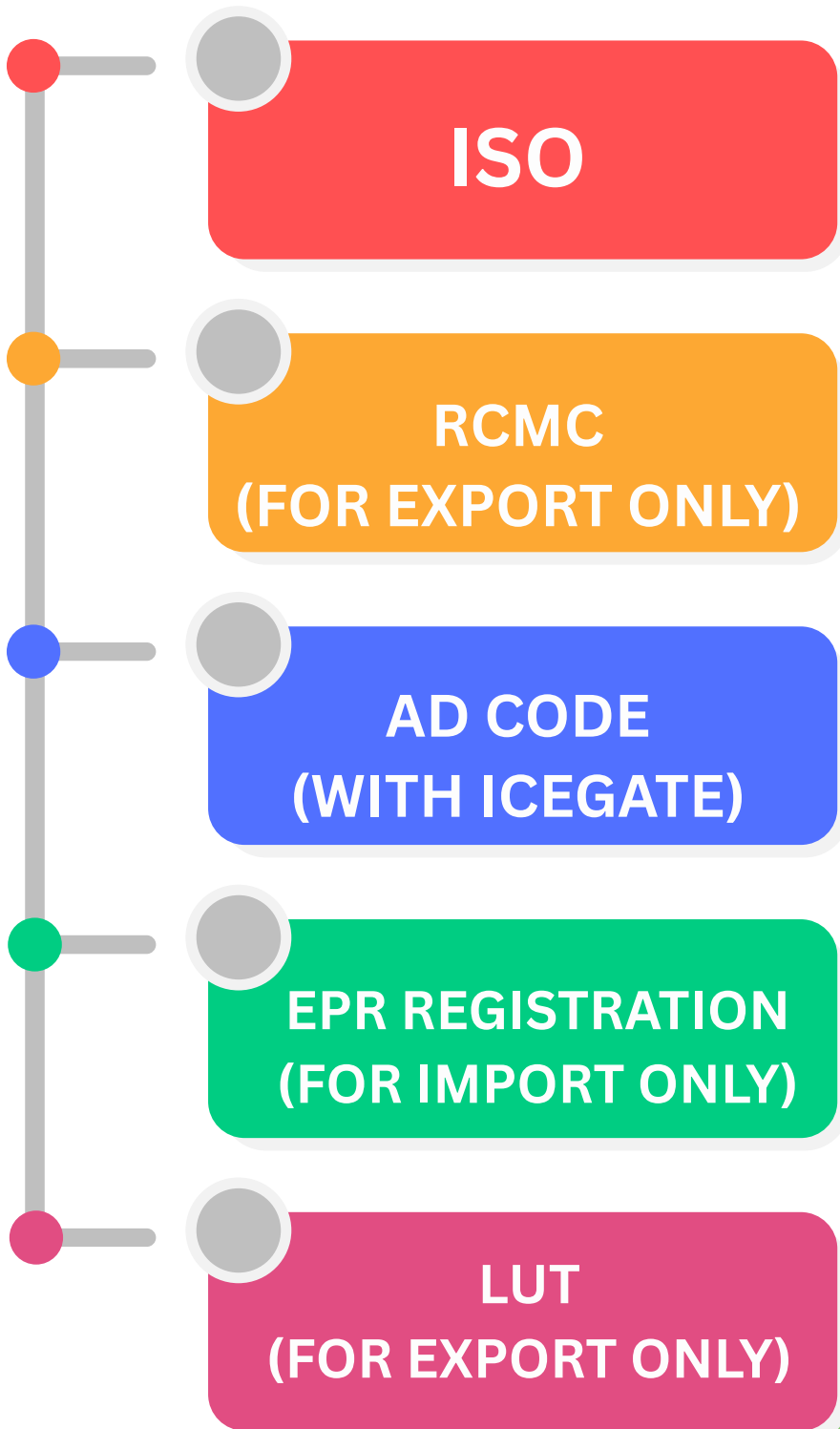

The DGFT department will verify and approve your application as per guidelines.
- 07 Get IEC CODE**  
Your IEC code will be issued within 2 working days if all documents are correct.

## **FREQUENTLY ASKED QUESTIONS**

### **01** Who needs IEC registration?

Any individual, company, or organization engaged in international trade (import/export) must obtain IEC.

### **02** What is the validity of an IEC?

IEC is issued for a lifetime and does not require renewal. However, it must be updated annually on the DGFT portal.

### **03** Can I modify or update my IEC details?

Yes, IEC details can be updated or modified on the DGFT portal. Updating IEC annually is mandatory.

### **04** Can IEC be canceled?

Yes, if you no longer require IEC, you can apply for its cancellation through the DGFT portal.
